Dear Mayor Steinberg,

We the undersigned national and local civil rights, faith-based, human rights, and community organizations, write to ask you to join us in publicly embracing our nation's core values of pluralism and religious freedom for all while firmly rejecting the forces of hate and bigotry that seek to divide us.

As you may be aware, ACT for America, the nation's largest anti-Muslim hate group, called for a protest in Sacramento as part of a coordinated series of protests in over 60 cities on September 9th. Timed near the anniversary of the September 11th attacks, ACT branded these events as "America First" rallies to explicitly target Muslims at a time when hatred and bigotry have swept the nation. ACT announced this week that it is canceling the rallies for September. This suggests that ACT fears backlash in the likely event white supremacists participate in the rallies and threaten or perpetrate violence.

ACT's support for bigotry is overt, and it has a documented history of attracting white nationalist support. ACT's founder, Brigitte Gabriel, regularly vilifies Muslims, claiming that practicing Muslims cannot be loyal to the United States. She also once said that "every practicing Muslim is a radical Muslim" and that Muslims are a "natural threat to civilized people of the world, particularly Western society." Both she and ACT have had a long history of promoting policies at the federal and state levels intended to manufacture fear of Muslims.

ACT held similar rallies on June 10th of this year that not only attracted anti-Muslim activists, but also a host of armed militia-type groups and white nationalists. At least two of ACT's scheduled protests for September 9th featured organizers who openly embraced white nationalism.

As the country recently witnessed in Charlottesville, Virginia, rallies organized to promote bigotry similar to events planned for September 9th can lead to states of emergency, physical violence and even murder. The horrific events in Charlottesville occurred despite a prepared response from state and local officials and law enforcement.

Although ACT has removed its endorsement and branding from any rallies that may take place, many of the rallies have already been organized, and may continue with or without ACT's brand attached. In light of this possibility, and recent events, we urge you to

unequivocally condemn white supremacist and anti-Muslim hatred and make it clear that bigotry and violence are not welcome in Sacramento.

We are deeply concerned about the type of message that anti-Muslim protests send to the American public and to the good people in your city--that it is acceptable to vilify people simply because of their faith.

Between 2014 and 2015, FBI data indicates that hate crimes against Muslims increased by 67%. Bias-motivated violence continues to target Muslims, Sikhs, Arabs, South Asians, and a number of other communities. Just this year alone there have been numerous murders of individuals who are Muslim or were targeted based on anti-Muslim bigotry, regardless of their religion. In addition, several mosques around the country have been targeted by arson. Incidents like these do not occur in a vacuum; anti-Muslim bigotry and violence is being fueled by hateful rhetoric and discriminatory policies at the highest level of government. The current atmosphere has also contributed to an environment in which children are the target of anti-Muslim sentiment, sometimes rising to the level of discrimination, intimidation, and harassment, impacting their right to attend school without fear.

Now, more than ever, we must come together and support one another from viewpoints and groups that seek to divide us.

Please do not stay silent in the face of bigotry and hate. As Americans take cues from their elected representatives, you are in a powerful position as a leader in your city to reject hatred and bigotry inspired by ACT.

We urge you to issue a statement to send a strong message that every person is welcome in your city and has the right to feel secure regardless of how they worship, where they're from, or who they love. Furthermore, we ask that you acknowledge that American Muslims have been an essential part of the fabric of our society since before our nation was founded. The members of your community, Muslim and non-Muslim alike, must be reassured that bigotry, hatred, and prejudice against any individual or group based on their faith, gender, gender identity, ethnicity, nationality, race, sexual orientation, or disability status will not be tolerated.

We look forward to hearing from you and hope that we can work closely with you in the future to positively engage all communities.
